- Any damage that occurs to the unit, furnishings or household items is the responsibility of the guest and he/she may be asked to reimburse owner for this damage. If linens go missing or are ruined, you will be assessed a replacement fee as follows: sheets: \$20 per set, towels: \$8 each.
- That agent or certified maintenance person may enter the premises for the purpose of tending to necessary repairs or maintenance.
- That guests acknowledges and understands that he/she is a licensee of the owner and not a tenant: and is not acquiring any interest in the property and that the use of the property is subject to the Owner's right of possession thereof.
